#### **PROCEDURE FOR PUBLIC PARTICIPATION BY ELECTRONIC MEANS:**

The public may participate in the meeting electronically and may make public comment joining the Zoom meeting. Attendees will be muted automatically except for the Call To Public portions of the agenda, where members of the public may use the "raise hand" function within the Zoom meeting application, at which point they will be unmuted for up to 5 minutes of public comment per person. If you are participating via telephone, you will need to press \*6 to unmute yourself during public comment. The Board President will determine the order of public speakers.
